The meeting convened at 7:33 PM.

Minutes from August 15, 2018 meeting were approved, as amended.

- 1. Peer Committee Joint Planning Guest: Park & Recreation Commission: Doug Thornton, Chair of the Park & Rec Commission and Bob O'Shea discussed what's currently going on with Park & Rec. The finances were in disarray due to the Beach and Park & Rec using 2 accounting reporting systems. Bob has put all transactions on one system (UniPay). With the new UniPay system, in place income will now have accurate reporting. They also presented a view of potential projects which might be able to utilize CPC funding (as follows):
 - Canoe/Kayak kiosk Due to lack of space, many residents are not able to get a
 rack at the pond. This may alleviate the problem. The proposal is to have a rack
 of 25 rental canoes/kayaks/paddle boards available for a nominal fee. The town
 would own the boats and rent them out via a kiosk. Approximate cost of \$5,000 \$10,000 for this system.
 - Park & Rec land between the General Store and Congregational Church the
 land between to 2 buildings outside the cemetery is Park & Rec land. After the
 filming, Park & Rec proposes putting a stone patio between the General Store
 and the entrance to cemetery. Park and Rec would work with Historic
 Commission for the creation of this park.
 - Ann Lee Road field the softball field will be renovated and brought back into useable shape. Rotate diamond, fencing and sand for the infield. Approximate cost of \$40,000.
 - Restoration of the Bromfield Stone Wall continuation of the restoration of the stone wall along Massachusetts Avenue to Pond Road. Wall may need to be shorter this currently is due to proposed sidewalk to be installed along Pond Road.
 - Fitness Course at McCurdy Track
 - Renovation of the Beach House at Bare Hill Pond

Park & Rec will prioritize these proposed projects and submit applications to CPC when ready.

- 2. Treasurer's Update: David Nalchajian has not sent John monthly reports regarding CPC funds. All sunseted projects (Harvard Park Trail, Hildreth House windows, etc.) have been transferred back to the funding source, giving CPC an approximately additional \$46,000 (restricted funds). CPC has approximately \$208,000 for distribution. John has submitted the CP3 reports to the Community Preservation Coalition.

- 4. Applications Received to Date: Two applications received so far.
 - a. Bromfield School Turf Project (amount to be submitted at later date).
 - b. Harvard Historic Commission to complete the restoration of the Bromfield wall along Mass Ave. (\$89,200).
