- 3. Treasurer's Report Stuart Saginor of the Coalition sent email today stating that \$20 million available for CPA from the consolidated net surplus of the Commonwealth. The Coalition confirmed that the \$20 million has already been transferred to the CPA Trust Fund. The Department of Revenue (DOR) confirmed that they will be recalculating the distribution that communities received back in November with the additional funding factored in. Communities will be receiving an additional distribution once these calculations have been finished, but there's still no official word on the timing. The Coalition is hopeful that this second distribution will be finalized by the end of January.
