Schools	 HES Project – After the Jan 23 HES Energy Design meeting, Brian suggested that HEAC ensure an Energy/HVAC Design FAQ with the most common questions or concerns be identified and answered by the Architect/Design team. Pending HES Existing Solar Panels –Jon Snyer identified that he would consider moving the system to the Auditorium roof. Any decision to put on the Bromfield roof has to be coordinated with replacement of several roof sections that are 20 years old. – Need a site that is feasible to accept the panels Pending Demand Response – Jon Snyer is leveraging the DOE Shines project at Bromfield to participate in the NGRID Connected Solutions program. The wireless bridge upgrades were completed to support additional circuit monitoring. Charging Station – Nate Finch to make a proposal for where to locate and how the charging is paid and communicate with NGRID for funding the project. He will also plan to communicate with stakeholders to determine the need and support for a specific location. – Nate to provide update at next meeting. School Committee update – Brian presented the annual Energy Committee status report on October 29. The gas usage at Bromfield was up higher for FY19 than expected even due to the cold winter. Jon Snyer has completed actuator replacements and rooftop units have been repaired at the end of the winter. Jon is also completing a boiler control project which should
