**REVIEW/APPROVE MINUTES OF LAST MEETING:** Minutes of June 27, 2018 meeting approved unanimously, Manny Lindo abstained

### **NEW APPLICATIONS:**

1. Richard Cummings, change color of house

15 Mass Avenue. Application to change color to historic color. Structure was built as a barn and converted to a house. Samples provided. Motion made and unanimously approved to treat this as a substantial change requiring a hearing.

2. Dan DiRocco, various changes including color

24 Fairbank Street. Application to change color of house to historic color. Replace roofing with red cedar shingles. Replace existing 9 vinyl windows on front of house with divided-light wood windows. Add copper gutters. Replace 2 light fixtures. Replace roof of bay window with copper sheathing. Alterations discussed and drawings examined. Owner asked to bring samples and pictures. Motion made and unanimously approved to treat application as substantial change requiring a public hearing.

23 Fairbank Street. Application to add solar panels to roof of house. Panels would cover most of front roof and part of back roof. Owner had first preferred barn as site for panels but was told by engineer that house would be better. Commissioners expressed some concern about the panels on the house and suggested another company that might have a different opinion about the barn. Motion made and unanimously approved to treat this as a substantial change requiring a hearing.

- 4. Erin Sullivan, addition to home
  - 5 Littleton Road. Application for renovation of existing "ell" and addition. John Kelly (architect) represented home owner and reviewed plans which attempt to visually tie addition to existing house. Will maintain current color scheme (house and ell are painted different colors). Reviewed materials for roof and windows. Discussed impact of addition from street. Motion made and unanimously approved to treat this as a substantial change requiring a hearing.
- 5. Suzanne Buchanan, Historic New England, preservation restriction of Houghton House,

204 West Bare Hill Road. Owner (Karla Pearlstein) requested that HHC approve a preservation restriction agreement between owner and the Society for the Preservation of New England Antiquities. Robert Adam described the restoration process undertaken over the last 10 years. Carissa Demore of SPNEA discussed the owner's desire to preserve certain aspects of the interior and exterior of the structure and how a preservation restriction agreement works. There was a discussion that verified absence of liability or responsibility of the town for enforcing or monitoring the restrictions. After concluding that it is in the best interest of the town to preserve this historic structure as desired by the owner, the commissioners unanimously endorsed the agreement which will be referred to the select board for signature.
