REVIEW/APPROVE MINUTES OF LAST TWO MEETINGS:

The minutes of the Oct 9, 2019 & Oct 30, 2019 meetings were approved as corrected by unanimous vote.

16 Ayer Road, Sandra Femino and Shawn McCollim, new barn door

NEW BUSINESS:

Discuss process for review and update of "Policies and Procedures" and "Design Guidelines"

It was decided that both the Policies and Procedures and the Design Guidelines need to be reviewed and updated. Manny and Pam will take the lead on the Design Guidelines and George and Richard will work on the Policies and Procedures. The goal is for these documents to be simplified and checked to ensure they are compatible with the Harvard Bylaw and the Commonwealth statute and guidelines. By unanimous vote it was decided to hold a public hearing in December to remove the exemptions on page 35 of the Policies and Procedures (under definitions). This provision removed the sidewalk project from HCC jurisdiction. Certain exemptions may be added back to the Policies and Procedures as part of the comprehensive review.

ON-GOING BUSINESS:

1. All boards meeting Sept 18, 2019, report from Pam

Pam reported to other town boards the HHC was working on a demolition delay bylaw which was met with approval.

2. Follow up on sidewalk project application

George reported that the Select Board would like guidance regarding design elements of the Safe Streets sidewalk project. Commissioners expressed the opinion that although HCC should have been consulted as to the overall design earlier in the process, they would be willing to answer specific design questions if asked by the Select Board.

Shields wrote with concerns about traffic flow near their home due to development however they do not live in the historic district.

Demolition Delay Committee: Discuss preparation for presentation for BOS, then ATM

George reported that most towns adopting bylaws are including a 12 or 18 month delay period and that many towns that had initially included shorter delays are lengthening the term. This led to a discussion about the appropriate delay for the draft bylaw for Harvard and the reasons for a shorter or longer term (the original draft proposed a 6 month delay). By a vote of 3 (George, Pam and Richard) to 2 (Steve and Manny) it was decided to include a delay period of 18 months in the Harvard bylaw. George reported that he will meet with the historical society board to inform them of the planned bylaw and enlist their support. Pam and others will think of ways (including a piece in the paper) to promote the bylaw before it goes to a town vote. George and Pam to work on a presentation to the Select Board. Demolition by neglect was also discussed. George reported that some towns have placed a demolition delay on a property only to have it be condemned because owners

intentionally allow it to deteriorate. Some towns have included a provision to address the issue of demolition by neglect which places a duty on the property owner to maintain the building in a condition that prevents its deterioration. There was a question as to whether Harvard already addresses this issue through its building code. Steve is to check into this.
