RESIDENT ADDRESS – If your Resident Address is incorrect, correct it on the lines to the right of the incorrect address.

PHONE NUMBER – Please print and/or verify your phone number in the indicated space. Check the box if it is Unlisted.

VOTER – Registered voters will have an Asterisk * in this column indicating that they are a voter. If there is no Asterisk* you are not a registered voter in Harvard.

NAMES OF ALL FAMILY / HOUSEHOLD MEMBERS AT THIS ADDRESS – Be sure to include ALL family or household members whose legal address is the same. Include any member of the family in Military Service, away at school or confined to a rest home. If a NEW member has been added to the household, enter his/her name & date of birth below the other residents.

DATE OF BIRTH: If the date of birth is incorrect please cross out and enter correct date.

OCCUPATION – Indicate/verify your occupation, not your place of employment.

NATIONALITY – Complete only if you are **NOT** a U. S. Citizen, please indicate/verify your nationality.

MOVED / DECEASED – Write “D” in this column for any deceased residents. Write “M” if a resident shown has Moved from this address **AND** complete the ****MOVED**** section at the bottom of the form with their new address. If they are a registered voter, we require their signature to remove them as a voter in Harvard. If they can't sign this form, we will mail them a confirmation card to sign.

VETERAN – Write “Yes” in this column for anyone who is a veteran of the U. S. Armed Forces.

PUBLIC SAFETY EMPLOYEE – Please write “Yes” if you are employed in a Public Safety occupation.

COMPLETE AND RETURN YOUR ANNUAL CENSUS FORM TO REMAIN AN ACTIVE VOTER.

Completing and returning this form provides proof of residence, protection of voting rights, veteran's bonus, housing for the elderly and related benefits as well as providing information for your community. **It DOES NOT register you to vote, or allow you to change your political party.**
