1. CPC Application

- a. BLeicher completed CPC Application for funding to match NRG Mass Trails grant funding to further expand the NRG trail network. 20% Town match required. NRG Mass Trails grant funding to cover 80%. CPC grant would cover the town's 20%. JLee to forward the Application to Park&Rec.

2. MART Stop(s)

 Harvard's annual MBTA assessment covers the cost of services in RFP. SB voted in favor of utilizing the MART service. SDonahue to follow up with MART on next the steps towards implementing.

3. DLTA-A funding update

a. At the September 7 MRPC meeting, MRPC reported they had contracted Dexterity Management to assist member municipalities with grant proposals. MRPC/Dexterity Management should be contacting TAC soon.

4. Transportation Related Projects Updates

- a. SUP between town center to Depot Fields JLee will be sending the .pdf's of the original project to the SB and will review with RMaiorie to see how to proceed. Should it go just to Town Administrator as a request or go to SB public meeting? JLee will review with RMaiorie. JLee to email TKilhart about executing in parallel with Devens water main project.
- b. GMedjanis met with TKilhart at the DPW to check status of the Ayer Road TIP project. 75% Plan comments sent to MassDOT, bump outs voted out by SB based on MassDOT feedback.
- c. NRG signage additions were not encouraged by DPW.
- d. The proposed SUP construction from Town Center to Depot Road and beyond during the Devens water main connection was noted is not currently budgeted for in the project.
